SUBJECT: Demand for deletion of extraneous columns in the Annual Confidential Reports of Teachers as introduced by Secretary Education vide his letter dated 11.3.2019

Dar Sir,

I am enclosing herewith a copy of the letter dated 11.3.2019 issued by Secretary Education Punjab to all the District Education Officers and School Heads. A perusal of the aforesaid letter shows that following two columns have been introduced in the Annual Confidential Reports through the aforesaid letter:-

“(1) ਜਿਹਨਾਂ ਅਧਿਆਪਕਾਂ ਦੀ ਸੰਤਾਨ ਨਹੀਂ ਹੈ, ਜਾਂ ਅਜੇ ਕੁਆਰੇ/ਕੁਆਰੀਆਂ ਹਨ, ਉਹਨਾਂ ਅਧਿਆਪਕਾਂ ਨੂੰ 10 ਨੰਬਰ ਦਿੱਤੇ ਜਾਣਗੇ !

(2) ਜਿਹਨਾਂ ਅਧਿਆਪਕਾਂ ਦੇ ਬਚੇ 10+2 ਤਕ ਸਿੱਖਿਆ ਪ੍ਰਾਪਤ ਕਰਨ ਦੀ ਉਮਰ ਲੰਘ ਚੁੱਕੇ ਹਨ,, ਉਹਨਾਂ ਅਧਿਆਪਕਾਂ ਨੂੰ ਵੀ 10 ਨੰਬਰ ਦਿੱਤੇ ਜਾਣਗੇ !”

2. A perusal of the aforesaid newly added columns shows that the criteria contained therein is not only arbitrary but ridiculous, and appears to have

been inserted/incorporated without any application of mind by the Education Secretary Punjab. These columns would only make the Government a laughing stock in case the matter goes to the Hon'ble Courts for adjudication.

I would therefore, call upon you to immediately direct the Secretary Education Department Punjab to withdraw the aforesaid amendment letter dated 11.3.2019, amending the ACR Performa of Teachers/School Heads.
