NOTICE BEFORE FILING CONTEMPT PETITION

It would be pertinent to submit that in LPA No. 6 of 2018 (Iqbal Singh Dhillon and others Vs. State of Punjab and others), decided on 9.1.2018, this Hon'ble Court had categorically directed the State Governments of Punjab and Haryana and the agencies appointed by them for recruitment of candidates as under:-

“At this stage, learned counsel for the appellants further pointed out that not only in the advertisement in question, rather in number of advertisements issued by the State Government for recruitment to different posts, the State Government/Commissions or any other selecting body to various posts, though the qualification required for the posts are mentioned, however, the relevant rules applicable for the same are not mentioned. The selections have to be made in terms of the rules laid down. The rules are to be clearly mentioned so that the candidates should have the opportunity to go through the rules as well.

Henceforth, it is directed that in all advertisements issued by the State Government or any of its Agency shall clearly mention the rules applicable for the posts prescribed, the qualification and also the link of

the website or the source from where any prospective candidate can obtain copy of relevant rules.”

A true copy of the aforesaid judgment dated 9.1.2018 is enclosed as **Annexure -1** with the instant Civil Writ Petition.

I WOULD THEREFORE CALL UPON YOU TO COMPLY WITH THE AFORESAID ORDER, IN RELATION TO ADVERTISEMENT NO.16 OF 9.3.2019 FOR POSTS OF PRINCIPALS AND HEAD MASTERS/HEAD MISTRESSES, AS MODIFIED BY CORRIGENDUM DATED 25.3.2019, AS NO LINK OR SOURCE OF STATUTORY RULE HAS BEEN MENTIONED THEREIN, AND I AM UNABLE TO LOCATE THOSE RULES ON ANY WEBSITE OF THE STATE GOVERNMENT(EDUCATION DEPARTMENT.

IN CASE THE NEEDFUL IS NOT DONE BY TOMMORROW MORNING, IN THAT EVEN, I SHALL BE CONSTRAINED TO FILE A CONTEMPT PETITION AGAINST YOU.

MEANWHILE, PLEASE ACKNOWLEDGE RECEIPT OF THIS NOTICE.
