In continuation of this Administration's letter bearing No.217-FII(12)/2009/367-369 dated 21.1.2009 on the above subject, it is clarified that decision providing free medical facility to all the surviving freedom fighters living in the Union Territory, Chandigarh includes their spouses also.

Further it has also been decided that in the case of emergency, any freedom fighter or his/her spouse will also be allowed to avail treatment from the private hospitals subject to compliance of the instructions issued by Chandigarh Administration in the matter of medical reimbursement for its employees and reimbursement of expenditure on their treatment shall be limited to the prescribed charges in the Government hospital or the P.G.I. on the pattern of Government Servants.
